The International Solar Alliance is a treaty-based international inter-governmental organisation of 121 solar resource rich countries.



The ISA was launched by H E Narendra Modi, Hon'ble Prime Minister of India, and H E François Hollande, former President of France, at the UNFCCC CoP21 at Paris on 30 November 2015. The ISA's major objectives include deployment of 1000GW of solar capacity and mobilisation of US\$ 1000 billion investment into the sector by 2030.

The ISA Framework Agreement came into force on 6 December 2017. **As of 20 July 2018, the Agreement has been signed by 65 Member Countries, and ratified by 33 Members.** The ISA is headquartered at Gurugram, India. H E Upendra Tripathy is the Interim Director General.
